Established in 1951, IOM is the leading inter-governmental organization in the field of migration and works closely with governmental, intergovernmental and non-governmental partners. The International Organization for Migration (IOM) is committed to the principle that humane and orderly migration benefits migrants and society. As the leading international organization for migration, IOM acts with its partners in the international community to: assist in meeting the growing operational challenges of migration management; advance understanding of migration issues; encourage social and economic development through migration, and; uphold the human dignity and well-being of migrants.

IOM has been active in Poland since 2002 under an agreement with the Polish government and conducts various migration programs, including activities supporting the integration of male and female migrants into Polish society. IOM in Poland implements projects aimed at the private sector to promote ethical recruitment, respect for the rights of migrants and migrant women as well as the elimination of forced labour from value chains and the prevention of human trafficking.

Context:

The conflict in Ukraine has led to the overspill of over a million forcibly displaced persons to Poland. As migratory flows continue unabated, IOM is urgently and significantly boosting its capacity in Poland to provide multi-sectoral assistance to respond to urgent emerging humanitarian needs in a dynamic context. There is an urgent need for the provision of accurate and up to date information on available services, as well as transportation for vulnerable individuals in need.

Under the overall supervision of the Emergency Coordinator, the Field Coordinator and the direct supervision of the SMS Coordinator, the successful candidate will function as the general point of contact for all matters pertinent to IOM interventions in the region of Podkarpackie. Staff members in field-based positions will be required to be mobile within the assigned Voivodeship when immediate project needs arise. This position is based in Rzeszow, with frequent travels to sites, collective shelters etc in the region of Podkarpackie.

Core Functions / Responsibilities:

1. Participate at regular field visits at the region of Podkarpackie along with IOM Mobile Team consisted of different specialties (SMS, Protection, Community Engagement services)
2. Liaise with local authorities, support coordination between relevant actors, and support the implementation of site improvement plans.
3. Provide information to refugees through established IOM help desks, coordinate, and support the work of other volunteers at crossing sites and ensure refugees are oriented after arriving on site.

4. Provide interpretation for effective communication between IOM staff and/or implementing partners and migrants, including during individual/ group sessions, community engagement activities, escorting.
5. Identify vulnerable refugees and support their referral to relevant protection services, including Third Country Nationals, unaccompanied minors, and single-female headed households.
6. Support in translating information materials/ documents and other needed information used for individual and/ or group activities in the migrant communities.
7. Perform other related duties that may be assigned.

Required Qualifications and Experience

Education

- High school degree/certificate with minimum two years of relevant work experience;
- University degree from an accredited academic institution in related field would be considered as an advantage.

Experience and Skills

- At least two years of in work related to above description, including interpretation and translation;
- Possess adequate combination of knowledge, education, training experience and skills to perform essential functions of the position;
- Computer literacy in standard software applications;
- Experience in working in a multi-cultural environment preferred;
- Strong work ethics and commitment to humanitarian principles;
- Valid driver's license with at least three years driving experience an advantage.

Languages

Fluency in **Polish, Ukrainian** and/or **Russian** is required, as well as good knowledge of **English**.
